SECTION III-APPLICANT'S CERTIFICATIONS

I hereby submit to JHAB this application for an ID Badge and agree to the following:

- **1.** To comply at all times with the security rules and policies of JHAB, including the provisions of Title 49, CFR, Parts 1540, 1542, and 1544.
- 2. All ID Badges remain the property of JHAB; My ID Badge cannot be transferred to another individual or used for any purpose by another individual; I will visibly display my ID Badge outside my garments on my upper body whenever I am in any area of the airport; I will not aid nor participate in "piggy-backing" (allowing unauthorized access to secure or restricted areas) nor will I otherwise breach, disobey or disregard any security directive, plan or program at the airport; I will challenge any person who enters a secured/restricted area if the person does not properly display an ID Badge. If the person I challenge cannot produce a valid ID Badge, I will immediately notify airport operations at 307-413-1519.
- 3. Use of the ID Badge constitutes consent to search and monitoring at any area of the airport. SCREENING NOTICE: Any employee holding a credential granting access to a Security Identification Display Area may be screened at any time while gaining access to, working in or leaving a Security Identification Display Area.
- 4. JHAB reserves the right to revoke authorization for an ID Badge where such action is determined to be in the best interest of airport security. You must immediately return the ID Badge to JHAB or your employer upon notification that your authorization has been revoked; I will immediately notify my Supervisor or JHAB of any unattended bags and or suspicious activity; I will immediately notify my employer if my ID Badge is lost or stolen. A non-refundable fee of \$150.00 will be assessed for replacement. JHAB will collect the fee before a replacement ID Badge is issued. Furthermore, a replacement ID Badge may only be issued if I declare in writing that the ID Badge has been lost, stolen, or destroyed. The ID Badge is the property of JHAB. You must immediately return your ID Badge to your employer or JHAB at the end of employment or upon receiving notification that your badge is being revoked. Failure to comply within 24 hours is in direct violation of the Airport Security Program ASP and you can be subject to a potential \$10,000 Civil Penalty Fine assessed by the Transportation Security Administration TSA under title 49 of the Code of Federal Regulations CFR Part 1540.105; 49 USC 46301.
- **5.** In the event of any change in my employee status (i.e. transfer, job title), I will obtain a new ID Badge noting the change and return the original ID Badge.
- **6.** I will immediately notify my Supervisor or JHAB if I am arrested of any of the crimes listed under Title 49, CFR, Parts 1542.209 or 1544.229.

I understand and agree to comply with the terms and conditions provided for in this application and agree to comply with any changes or amendments to the terms and conditions that may be imposed by JHAB. The information that I have provided on this application is true, complete, and correct to the best of my knowledge and belief and is provided in good faith. I understand that a knowing and willful false statement on this application can be punished by fine or imprisonment or both. Jackson Hole Airport Employee Parking Regulations

As an employee of the Jackson Hole Airport or an employee of a stakeholder at the airport you are required to park in the Overflow lot anytime you are working at the airport. Your airport issued badge will allow you to enter and exit the lot. It also provides you with a 24hr rate of 50% off. You must use your badge to enter the lot for it to allow you to exit. For example, if you arrive for work and there is an issue with your badge so you decide to pull a ticket to enter, your badge will not allow you to exit. This type of issue along with any other parking related problems need to be addressed immediately with Airport Operations personnel. Delaying reporting these issues or that you are going to be over the 24-hour window due to work will cause time delays with your exit from the lot.

Our operations personnel must investigate every reported issue to ensure system accuracy and well as the legitimacy of a request to forgo paying any amount due. Also, to ensure analytics and capacity are being addressed properly your requirement to park in the overflow lot for work will be monitored. This measure is to allow our staff to adequately provide parking to our passengers and community alike. Below is a map of the parking areas and if you have questions, concerns, or issues you should contact Landside Operations at (307) 413-1516 immediately.

By signing this agreement, you are acknowledging you have read and understand that you are obligated to park in the overflow lot while working at the airport and that failure to do so could result in revocation of parking privileges, other access privileges as well as associated discounts.
