




INCOME/EXPENSE FISCAL YEAR END JUNE 30, 2025





INCOME/EXPENSE JULY 1, 2025 – JULY 31, 2025







- Total construction cost of \$445,000






JAC OPERATIONS 2021-2025





JAC ENPLANEMENTS 2021 – 2025






